The Islamic Republic of Iran has received financing from the World Bank toward the cost of the Alborz Integrated Land and Water Management Project, and it intends to apply part of the proceeds toward payments under the contract for construction of canals and drainage system and related structures. The Ministry of Jihad-e Agriculture now invites sealed bids from eligible bidders for Procurement of TALAR Right Bank Irrigation and Drainage Tertiary System (IDM/W301). The construction period is 24 months.
